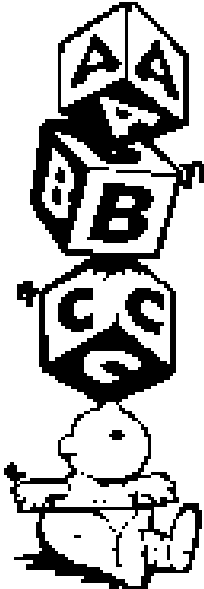

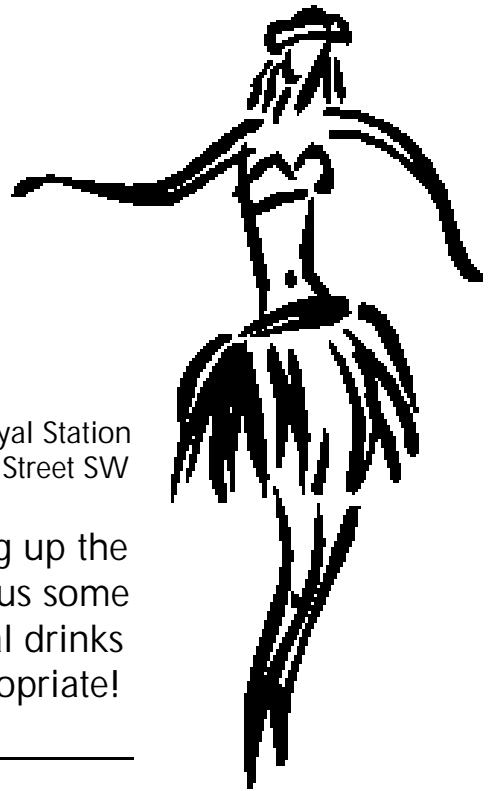

# Traffic Safety Report

## JANUARY TRAFFIC UPDATE

## Q&A

*Q. A friend of mine knows a guy whose brother's neighbour has loud parties late into the night. Isn't there a law about what time a party has to end?*

A. There are two laws at play here. The first, known as the Law of Libation Deletion, generally holds that a party, and the noise associated with it, ends twenty minutes after the last of the beverages are consumed. The second law, known as City of Calgary Bylaw Number 45M95 deals directly with the noise (but not the party itself). The bylaw deals with two types of noise, whether caused by a party, a dog, a child, a leaf blower, bagpipe practice or any other source. The two types of sound are "continuous sound" and "non-continuous sound". The former is defined as any sound level that occurs for a continuous duration of more than 3 minutes or sporadically for a total of more than 3 minutes, in any continuous 15 minute time period. Non-continuous sound (*are you ready for this?*) is defined as any sound level that is not a continuous sound.

One must not cause or permit to be caused a continuous sound that exceeds 65 decibels measured over a one hour period during daytime (between 7am and 10pm weekdays and between 9am and 10pm weekends) or 55 decibels measured over a one hour period during nighttime (between 10pm and 7am weekdays and between 10pm and 9am weekends).

One must not cause non-continuous sound that exceeds 85 decibels measured over a period of 15 minutes during the daytime or 75 decibels measured over a period of 15 minutes during the nighttime.

**FREE TRANSLATION:** keep the volume down after 10pm.

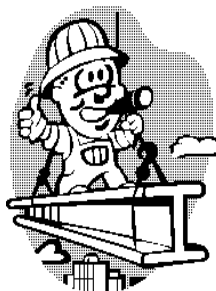
If the party is annoyingly loud after 10pm (and it is not being hosted by a member of the community association executive), you may wish to speak (or yell) to the host, and failing satisfaction from the host, contact the police.

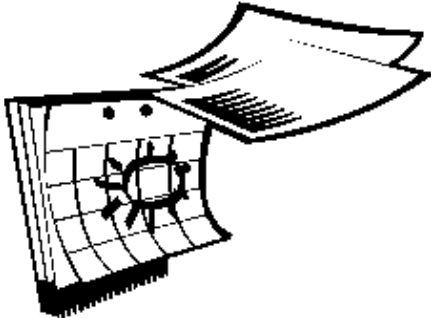
